In view of the massive outbreak of the COVID-19 pandemic, social distancing is a norm to be followed. The Annual General Meeting ("AGM") of the Company was held through VC/OAVM and the voting for items had been transacted as per the Notice to this AGM was only through remote electronic voting process and electronic voting during the AGM, in compliance with applicable provisions of the Companies Act, 2013 (including any statutory modification or re-enactments thereof), and the MCA Circulars dated 8<sup>th</sup> April, 2020, 13<sup>th</sup> April, 2020 followed by Circular dated 5<sup>th</sup> May, 2020 and Circular dated 13<sup>th</sup> January, 2021 (collectively referred to as "MCA Circulars") and SEBI Circular dated 12<sup>th</sup> May, 2020 and 15<sup>th</sup> January, 2021.

The venue for the AGM was deemed to be held at the Registered office of the Company at Synergia IT Park, Plot No-R-270, T.T.C. Indutrial Estate, Near Rabale Police Station Navi Mumbai – 400701.

#### 1. Dispatch of Notice convening the Meeting.

Pursuant to the MCA and SEBI Circulars, the Notice of the AGM along with the Annual Report for FY 2020-21 was sent on 30<sup>th</sup> August, 2021 by e-mail to Shareholders who had registered their email- id's with Depositories/the Company. #### 2. Cut-off Date

The Voting rights were reckoned as on 17<sup>th</sup> **September**, 2021 being the cut-off date for the purpose of deciding the entitlements of Shareholders at the remote e-Voting.

# 3. e-Voting

# i. Agency:

The Company has appointed National Securities Depository Limited ("NSDL") as the Agency for providing the e-Voting platform.

# ii. Remote-Voting:

The remote e-Voting platform was open from 09:00 A.M. on Tuesday, 21<sup>st</sup> September, 2021 and ended on Thursday, 23<sup>rd</sup> September, 2021 at 5:00 p.m. and shareholders were required to cast their votes electronically conveying their assent or dissent in respect of the Ordinary, on the e-Voting platform provided by NSDL.

#### 4. Counting Process:

i. The vote cast under remote e-Voting facility was thereafter unblocked in the presence of two witnesses who were not in the employment of the Company. I have scrutinized and reviewed the remote e-Voting and votes tendered therein based on the data downloaded from the NSDL e-Voting system.
