The proviso to section 68(2)(c) of the Companies Act, 2013, as amended, and Regulation 4(i) of the Buyback Regulations state that the buy Back of equity shares in any financial year shall not exceed 25% of the total paid up equity share capital of the Company in that financial year. The indicative number of equity shares to be bought back at the maximum buy back size and the maximum buy back price is 10,81,081 equity shares, which does not exceed 25% of the total paid up equity share capital of the Company as on March 31, 2018. If the equity shares are bought back at a price below the maximum buy back price, the actual number of equity shares bought back could exceed the indicative Maximum Buyback Shares (assuming full deployment of Maximum Buyback Size) but will always be subject to Maximum Buyback Size.
